DRUMS ALONG THE HUDSON® June 1, 2025

DISPLAYS & CLEAN-UP:

Displays must be attended at all times, kept in good taste, maintained, and cleaned up completely at the conclusion of the festival. Participants are responsible for removal and disposal of refuse.

SET-UP:

Environmental Tent participants can arrive to set up their tables starting at 10:00am. No vehicles will be permitted on park grounds to unload and pack up materials for Environmental Tent participants. Materials can be dropped off at the entrance to the park at the Welcome Tent, and volunteers will be available to help transport materials to the Environmental Tent for set up.

BREAK-DOWN:

All items should be removed from the park by 7:00pm.

SALES:

No Environmental Tent participants will be allowed to sell any items.

DAMAGES TO PROPERTY:

Damage, caused by participants, to trees, lawns or any other Parks property will result in fines.

GLASS BOTTLE PROHIBITION:

The sale of beverages in glass bottles is strictly prohibited on NYC park land.

VIOLATIONS:

Any applicant who violates **any** of the terms and conditions of this application may lose the privilege of participating in the event, without refund, and may be subject to summons or fines (or both) in accordance with the regulations of the New York City Department of Parks and Recreations.
